For bookings less than 60 days in advance of departure, Final Payment (including Deposit and Initial Payment) is due immediately upon booking.

For all other travel (including Umrah travel):

Deposit Amount: 25% of full package price due 120 days prior to departure.

Initial Payment Amount: Next 25% of full package price due 90 days prior to departure.

Balance: 50% of full package price due 60 days prior to departure.

Your booking is not confirmed until your registration/application is approved by DAR EL EIMAN TRAVEL at its sole discretion, the Deposit is received by DAR EL EIMAN TRAVEL and you receive written confirmation of your booking from DAR EL EIMAN TRAVEL.

Your reservation may be automatically canceled if payments are not received by DAR EL EIMAN TRAVEL by the applicable deadlines above.

### **Cancellation.**

Pre-paid packages, high-season packages, and customized packages are non-refundable. For all travel and tour packages, including Hajj and Umrah, all cancellation requests must be received by DAR EL EIMAN TRAVEL in writing.

You acknowledge and understand that DAR EL EIMAN TRAVEL incurs significant expenses and losses if a traveler cancels a booking. You expressly understand that the following cancellation fees will apply and be strictly adhered to by DAR EL EIMAN TRAVEL:

- (a) At least ninety (90) days before scheduled departure date: \$500 per person cancellation fee.
- (b) At least sixty (60) days before schedule departure date: \$1,500 per person cancellation fee.
- (c) Less than sixty (60) days before scheduled departure date: no-refund will be provided on any reservation.

In addition to the above-noted cancellation fees, airfare purchases are nonrefundable and any such amounts shall not be reimbursed to any traveler canceling a booking.

### **Travelers Who Need Special Assistance.**

**Mandatory Negotiation, Mediation and Arbitration of disputes; Waiver of Jury Trial and Punitive Damages.**

In the event of any controversy or claim arising out of or relating to this Agreement or any other contract between yourself and DAR EL EIMAN TRAVEL , or the breach thereof, the parties hereto shall consult and negotiate with each other and, recognizing their mutual interests, attempt to reach a solution satisfactory to both parties.

If they do not reach settlement within a period of 60 days, then either party may, by written notice to the other party, demand mediation in Jersey City, New Jersey exclusively, before a mediator mutually agreed upon by the parties.

If settlement is not reached within 60 days after service of a written demand for mediation, any unresolved controversy or claim arising out of or relating to this contract shall be finally resolved by arbitration administered by the American Arbitration Association under its Commercial Arbitration Rules, and judgment upon the award rendered by the arbitrators may be entered in any court having jurisdiction.

The arbitration will be conducted in the English language in Jersey City, New Jersey, in accordance with the United States Arbitration Act. There shall be three arbitrators, named in accordance with such rules.

Except as may be required by law or to the minimum information necessary for entry of judgment, neither a party nor its representatives may disclose the existence, content, or results of any arbitration hereunder without the prior written consent of all/both parties.

**The parties understand and agree that mediation and arbitration shall be the exclusive remedy for any controversy or claim arising out of or relating to this Agreement or any other contract between you and Dar El Eiman**

**All parties agree to irrevocably waive their respective rights to a jury trial of any cause of action, claim, counterclaim, or cross complaint in any action or proceeding and/or hearing brought by either party against the other on any matter whatsoever arising out of these Terms & Conditions or any agreement between you and Dar El Eiman Travel.**

In the event that the arbitration clause contained herein is deemed invalid by a court of law, each party agrees that **any suit, action or proceeding arising out of or relating to this Agreement shall be subject to the exclusive jurisdiction of the state and/or federal courts located in the County of Hudson, State of New Jersey.**

Each party waives any objection which it may have now or hereafter to the laying of the venue in the **County of Hudson, State of New Jersey** of such action or proceeding and irrevocably submits to the personal jurisdiction of any such court in any such suit, action or proceeding.

### **General**

If any of these Terms & Conditions is in invalid or unenforceable, only the portions of the provisions deemed invalid or unenforceable will be struck out, and the remaining provisions will remain in force.

Accessing or using the Website in any manner, or booking any travel products or services through the Website or through our customer service agents, is unauthorized in any jurisdiction that does not give effect to all provisions of these terms and conditions, including, without limitation, this paragraph. Headings are for reference purposes only.

Notwithstanding any other provision contained herein, if DAR EL EIMAN TRAVEL does not act in relation to a breach by you or others of these Terms & Conditions, this does not waive **Dar El Eiman Travel'**s right to act with respect to subsequent or similar breaches.
